- H2O Large Hydration Bladder Pack (Water Backpack)*** (THIS IS NEEDED! TEXAS IS HOT!!!)
- Sleeping Bag *** (Provided to International Students only)
- 1 pair of binoculars
- 1 flashlight with spare batteries and bulbs
- 3-5" lock blade with knife
- Backpack large enough to pack supplies for one overnight campout
- Money for incidentals (for flying back extra luggage, souvenirs, etc.)

I understand the risks, hazards, and dangers of hunting and have had the opportunity to discuss them with **INDIANHEAD RANCH, INC.** I understand that these activities may require good physical conditioning and a degree of skill and knowledge, I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely, I understand that I have responsibilities.

Apprentice Camp Requirements

The Goal of the Indianhead Ranch Apprentice Camp is for you to become a Hunter by obtaining your Hunter's Education Certification

1. PRIOR TO CAMP:

PRIOR to your Arrival at Indianhead Ranch Apprentice Camp you will have to complete the Home Study Course from the Texas Parks & Wildlife. There are two ways of doing this:

If you are a Web User:

Log on to the Texas Parks & Wildlife Department Website: www.tpwd.state.tx.us go to the page "education" on the Hunting & Wildlife Page go to "Hunter Education" "Online Course" "TPWD website" and click on "Let's get started".

You will have to Study the 9 Sections of the Course and take the 11 Quizzes at the end of these sections. Print out the Results, keep a copy and mail the other one to Indianhead Ranch in the return envelope that you received from us in your Camp Application Package. This will cost an additional \$25 for the study materials.

The Section #8 about Texas Regulations must be studied in the Texas Outdoor Annual Hunting & Fishing booklet that you received from us in your Camp Application Package.

Non-Internet User:

Please contact Indianhead Ranch Tel 830-775-6481 Fax 830-774-1528 to have the Home Study Course Materials mailed to you (Hunter's Field Guide, Hunter's Field Guide Workbook, Safeguarding our Heritage Video and the Quizzes). This will cost an additional \$25 for materials.

You will have to study the workbook, the field guide and watch the video to complete the 11 Quizzes. Once they are completed, make a copy for your records and mail the other one to Indianhead Ranch in the return envelope you received with your Camp Application Package.

The Section #8 about Texas Regulations needs to be studied in the Texas Outdoor Annual Hunting & Fishing booklet that you will receive with your Camp Application Package.

NOTE: Indianhead Ranch Apprentice Camp Program will not be able to accept you into its Field Course and Final Testing if you did not take and print out ALL of the 11 Quizzes of the Home Study Course PRIOR to your Arrival at Camp.

2. AT CAMP:

While at the Indianhead Ranch Apprentice Camp you will review some of the sections you studied at Home, but most of your time will be spent outdoors to complete the Field Course part required for the Hunter's Certification. You will have to show the results of ALL the Quizzes to be accepted. At the End of the Camp you will take the Texas Hunter Certification Written Test, 80% correct answers are needed to pass.

3. HUNTER EDUCATION CARD:

Upon successful completion, you will receive a Temporary Card. Your permanent Card will be mailed out directly to your Home Address.
